## Announcement regarding a possible offer for Dignity

On 4 January 2023, Dignity made an announcement confirming it had received a proposal from Yellow (SPC) Bidco Limited ("**Bidco**"), a newly formed company indirectly owned or controlled by SPWOne V Limited ("**SPWOne**"), Castelnau Group Limited ("**Castelnau**") and Phoenix Asset Management Partners Limited ("**PAMP**", and together with SPWOne and Castelnau, the "**Consortium**"), regarding a possible cash offer for Dignity of 525 pence per Dignity share (the "**Proposal**").

The Board of Dignity (the "**Board**") has considered the Proposal and indicated to Bidco that it would be willing to recommend to Dignity shareholders an offer on the financial terms of the Proposal, subject to the agreement of other customary terms and conditions. Accordingly, the Board is in discussions with Bidco in relation to these other terms and conditions and will be providing Bidco with access to management and confirmatory due diligence information.

Relevant persons who deal in the relevant securities of the offeree company or of a securities exchange offeror prior to the deadline for making an Opening Position Disclosure must instead make a Dealing Disclosure.

A Dealing

Disclosure by a person to whom Rule 8.3(b) applies must be made by no later than 3.30 pm (London time) on the business day following the date of the relevant dealing.

If two or more persons act together pursuant to an agreement or understanding, whether formal or informal, to acquire or control an interest in relevant securities of an offeree company or a securities exchange offeror, they will be deemed to be a single person for the purpose of Rule 8.3.

Opening Position Disclosures must also be made by the offeree company and by any offeror and Dealing Disclosures must also be made by the offeree company, by any offeror and by any persons acting in concert with any of them (see Rules 8.1, 8.2 and 8.4).
