# Announcement regarding a recommended cash offer for Dignity

On 23 January 2023, Dignity and Yellow (SPC) Bidco Limited ("**Bidco**"), a newly formed company indirectly owned or controlled by SPWOne V Limited, Castelnau Group Limited ("**Castelnau**") and Phoenix Asset Management Partners Limited ("**PAMP**") (the "**Consortium**"), announced that they have reached agreement on the terms of a recommended cash acquisition pursuant to which Bidco shall acquire the entire issued and to be issued share capital of Dignity, other than Dignity shares already owned or controlled by Castelnau and PAMP (the "**Offer**").
